In order to apply and obtain a SOLICITING, HAWKING, or PEDDLING PERMIT in the BOROUGH of BERWICK, PENNSYLVANIA you must log onto the Pennsylvania State Police P.A.T.C.H. web site listed below; open an account and request a "New Record Check" for yourself. Every person/s that will be soliciting, hawking or peddling MUST apply for this "New Record Check" for them self and each submit it along with the Borough's application and Waiver/Release form.

The Borough charges \$50.00 for each request.

Why does PATCH exist?

Its purpose is to better enable the public to obtain criminal history record checks. The repository was created and is maintained in accordance with Pennsylvania's Criminal History Information Act contained in Chapter 91 of Title 18, Crimes Code. This Act also directs the Pennsylvania State Police (PSP) to disseminate criminal history data to criminal justice agencies, non-criminal justice agencies and individuals on request. Criminal justice agencies can access all of an individual's criminal history record information (CHRI). Requests made by noncriminal justice agencies and individuals are subject to edit criteria contained in the law.

The PATCH web site is available for registered and non-registered users wishing to acquire criminal history information on individuals. Users must agree to abide by all sections of the Criminal History Record Information Act and all terms stated forthwith.

<u>There is a \$10.00 non-refundable fee for each request, regardless of outcome</u>. Payment is accepted by credit card or by billing a pre-established account. Customers will be charged for misspelling, duplicate submissions and other user errors. There is an additional \$5.00 non-refundable fee for a notarized copy. (Notarized copy not needed.)
